- I. **Call to Order/Roll Call: IVRPD Board:** Lindsey Buis-Kelly, Matt Cerney, Dan Litchfield., and Doti McDowell. Administrator: Kristina Hardin

- IV. **Public Comment:** Dave Zappa requested permission to chain the playground table to the ground. The board agreed. Dave also suggested that, in the future, the board would get 8 more security cameras. Those additional cameras would cover almost the entire center grounds. The board agreed that this makes sense.

  - a. The decided date for the Festival of Trees 2013 (FOT) is Saturday December 14.
  - b. The Community Supper went okay – there were complaints that there was not enough main dish food. Matt promised that will do better if we do this again.
