- a. *Transfer of funds. \$2,000.00 from the 10710 to 10100 for payroll and past due workman's comp fees of \$539.02 to the 10100 account.*: Nancy makes a motion to transfer funds of \$2,000.00 from 10710 to 10100. Matt seconds the motion. All in favor. 4-0
- b. Doti added that the trees at the pool have been cut down. The wood from the tree will go towards memorial benches, fence and banner.
- XIV. Community Center Committee Update.**
- a. *Create dates to create structure for new mirrors (Are the mirror approved for the main hall?) & possible attic cleanup. A walkthrough of upstairs to plan cubicles. (indoor cleanup and maintenance)* : The mirrors are cleared to be put up. Dave would still like to mount them in a more secure structure before putting them up. After the walk through. Plan is to build 5-6 length cubical boxes to allow each agency their own space to put their items.

Board member will bring their input and plan for the design will be put into place.*: after discussion the board agreed to clean out the old garden and take fencing down and prep to build fence. This will be known as faze one. At the next meeting we will discuss and take action on this plan for our new court yard. We will also appoint a committee to move forward with plan at their convenience.
